# **Presidents Report**



Sadly, last August another Life Member passed away. While he held a number of official roles in SAMA during the 1980s and 90s, **Paul Boyce** was best known as one of the quiet achievers over many years - always willing to help when something was needed to be done.

The COVID-19 Pandemic had a tremendous impact on our club, with the cancellation of the SAMA Summer Championships and the 2020 AMA T&F Championships in Brisbane, and the deferment of our summer presentations and AGM. It also caused a delay in the commencement our 2020 Winter competition, but we were fortunate to have the opportunity to take part in virtual competitions in the meantime. In particular, I thank George White and John Hore for their contributions to running the SAMA Virtual Winter Competition, which had an average of 30 -35 members taking part over 10 weeks.

### Athletic Activities

#### **Competition**

International competition included the Oceania Masters Athletics Championships held in Mackay, Queensland from 31 August to 7 September 2019, where a small contingent of SAMA athletes contributed to the achievements of the Australian team, attaining 16 gold, 7 silver and 13 bronze medals.

Before it was curtailed prematurely, we had a very successful and enjoyable Track & Field program in the 2019/20 year, despite having to cancel the SAMA competition twice due to excessive heat (including our Xmas break-up). Eight SAMA competitors braved the heat to participate in the 800m Masters event at the Bay Sheffield at the end of December! Congratulations to **Paul Lainio** who was first to cross the line, ahead of **Jamie Wilkinson** and **Wayne Scarman**.

Many State records were surpassed during the summer season, and **Colin Hainsworth** set a new Australian record in February (M90, 2000m Walk), and well as multiple M90 State records in the track walks. Ros Lowe has continued to do an excellent job in maintaining our Records database.

Thanks to the efforts of Viddy Jermacans we saw the introduction of the Bob Clarke Memorial Challenge, a distance-handicapped event in which sprinters and distance runners competed against each other over three rounds. It was a very exciting Final race between the 9 qualifiers, attended by Bob's son Brian Clarke who presented the prizes. The winner was **Richard McMahon**, closely followed by **Jenni Cotter** and **Sarah Chinner**. Congratulations to all that took part.

In the 2019 winter season we again hosted the National 20km Walk Championships with representation from four States/Territories. Our gold medallists were **Marie Maxted**, **Richard Everson**, and **Greg Metha**. The event was held together with the

SAMA Club Walk Championship and Half Marathon Run Championship. SAMA has been awarded the AMA 20km Walk Championships for the 2019-2021 triennium. The start of the 2020 Winter Season had to be delayed until mid-June, when restrictions associated with COVID-19 started to be eased. Initially competition had to conducted under severely restricted conditions. Fortunately, further easing of the COVID-19 restrictions has allowed us to conduct our Winter Championship events successfully.

During the year SAMA extended an offer to all ASA members 30 years of age and over to compete with us without the need to become members of SAMA. This included our competition on summer Wednesday nights and winter Saturday afternoons as well as our State Masters Championships.

#### Athletics Awards

We held a very successful inaugural SAMA Achievers Award in the summer season, which recognised the achievements of our athletes who strive from week to week to improve their performance ratings. I thank Graham Harrison and John Hore for their superb efforts in devising and implementing this points-based award. Congratulations to **Malcolm Tiggemann** who was the overall winner with the highest total award points score. He was closely followed by **Vicky Caputo** (2nd place) and **Ros Lowe** (3rd place). It was a close contest in the end and each awardee can be proud of their achievement.

Each year the SAMA Athletics Awards are made for athletic excellence in our club. Congratulations to all the winners and runners-up for 2019, who were to be acknowledged at our 2019/20 Summer Presentation Night, which had to be cancelled. Instead the winners are to be presented with their trophies at the 2020 AGM. A full summary of the 2019 SAMA Athletics Awards appears later in this Report, which lists the Awardees, and the reasons they were chosen by the SAMA Committee.

The winners of the SAMA Awards went on to be nominated for the equivalent Australian Masters Athletics (AMA) Awards for 2019. Congratulations to **Miriam Cudmore** (Winner of the AMA Most Outstanding Female Athlete Award) and **Allan Mayfield** (Winner of the AMA Middle Distance/Steeplechase Award) who were acknowledged at the virtual AMA awards ceremony presented on-line in April 2020, since the Brisbane Nationals had been cancelled.

SAMA members also had success in the Athletics SA 2019/20 awards that were presented in May 2020 in a series of virtual events due to the COVID-19 restrictions on large gatherings in place at that time. **Karen Pienaar** and **George White** (Winter awards) and **Miriam Cudmore** and **Allan Mayfield** (Summer awards), were announced as Female & Male Over-35 Athletes of the Year in their respective categories. Also, our **Ladies' T&F team** were the 035 Female Summer Premiership winners, and **Paul Greenwood** received the Emerging Official of the Year trophy.

### Finance

SAMA continues to enjoy a sound financial position, as will be evident from the separate Treasurer's report. We are grateful to Graham Billett for auditing our accounts again this year.

At last year's AGM there was strong feeling voiced by the members present that the Committee should be putting more of the funds accumulated by SAMA over the years towards providing tangible benefits to all club members. It was proposed that a good way to start would be to subsidise the breakfast provided to all those involved in the 20km Walk Championships (National and State) and Half-Marathon State Championships held in August.

The Committee also agreed to provide additional financial support to members by paying the team entry fees for the athletes representing SAMA at the relay events organised by Athletics SA, both in winter and summer seasons. We also embarked on the process of replacing some of our competition equipment that has reached its use-by date.

### Administration

I wish to thank all our helpers, volunteers and officials during both our winter and summer seasons, whose dedication makes our competition possible – we could not do it without you!

**Lisa Attenborough** was the deserving recipient of the 2019 SAMA Award for Most Outstanding Administrator / Official in recognition of her contribution to the running of our organisation for the past 5 years, most recently in her roles as Treasurer and Registrar, and as a key member of our officiating team.

I would also like to acknowledge the great work done by the 2019/20 SAMA committee throughout their term, and I was grateful for their support and willingness to extend their contribution to the smooth running of the club in the face of the challenges presented by the COVID Pandemic.

Sadly, we see the departure of five SAMA Committee members at the 2020 AGM; Helen Suridge, Viddy Jermacans, Jan Layng, Julia Lycett, and Marie Maxted.

Helen has done two stints as club Secretary, initially for three years from 2000, and more recently since 2016. She now wishes to devote more time to other things now that she is retired. I thank her for the wonderful job she has done in that role for a total of seven years. Fortunately, Helen is willing to continue as Social Organiser, a job she has done so effectively and with passion over the past two decades!

Viddy, Marie and Julia have served on the Committee since 2018, with Jan joining in 2019, and they have all made valuable contributions in their respective positions of Vice President, Awards Officer, Field Coordinator and Uniforms Officer. I thank each of them for their great work during the past two years.

I shall also be standing down as President at the AGM, but I am willing to continue serving on the 2020/21 Committee.

### Communication

The Marketing & Communications project that involves a number of athletics organisations in South Australia (originally under the banner of SA Athletics Alliance) has made good progress in its implementation stage, and SAMA has been ably represented by Paul Lainio on the working group. A brand and logo are being designed, and the web portal development is well underway.

This project aims to improve the ability of current and potential participants to engage in Athletics through developing a 'one stop shop', where anyone wishing to participate can find information on all athletics opportunities in SA in a single place.


